
PROJECT DESCRIPTION

Konrad-Adenauer-Stiftung (KAS) Jordan Office and West Asia-North Africa Institute (WANA) are launching a joint project for the third year titled: "Public Policies for Innovation in Jordan: Realities and Ambitions." The project seeks to engage Jordanians to produce public policy papers that will contribute to meaningful dialogues on public policies in Jordan.

The theme of "Innovation" reflects the need for novel thinking and approaches to the challenges and problems Jordanians face every day. Whether we address education and workplace policies, green technology, civic engagement, scarcity of water resources, entrepreneurship, or economic growth, these topics require innovative thinking with practical solutions. The project, therefore, aims to raise awareness of the Jordanian policy landscape and offer a non-governmental perspective on these issues.



PROJECT GOALS AND REQUIREMENTS



THE PROJECT'S GOALS ARE TO

- Address the public policy-making gaps in Jordan by devising policy recommendations and solutions to issues of relevance to innovation.
- Build the capacity of Jordanians to enable entry to market or policy research.

TO ACHIEVE THESE GOALS, WE EXPECT THE PARTICIPANTS TO:

- Attend the required training and present their work to their peers and to the invited stakeholders in a roundtable discussion.
- Adhere to the deadlines stated below and be comfortable sharing their work with their peers.

WANA and KAS will provide guidance and feedback along the way. However, it is the participant's responsibility to conduct their research and to write their paper. We will be working in our own professional learning community to facilitate this process. We will set up an account on a Learning Management Systems (https://canvas.instructure.com/). Each participant will be grouped with other participants, and you will be working closely during the project. The goal of your work together will be to push each other's thinking and provide alternative perspectives, views, and interpretations. This collaborative work will mirror the kind of work researchers engage in when they share their papers with their communities and the world.
